IN THE MATTER OF a Hearing to levy assessments in Countywide Landscaping District 1979-3 (LL-2) Fiscal Year 2021-22, (Countywide Landscaping District 1979-3 (LL-2) Funds) (All Districts) (Project Number 4500-6X5105).

WHEREAS the Board of Supervisors of Contra Costa County FINDS THAT:

- 1. - 3. A Resolution of Intention (No. 2021/126) was approved by the Board of Supervisors on May 11, 2021, which among other things set the date of June 8, 2021, for a Public Hearing at 9:00 a.m. in the Chambers of the Board of Supervisors of Contra Costa County administration Building, 1025 Escobar Street, Martinez, California; and
- 4. A Public Hearing was conducted on June 8, 2021, at 9:00 a.m. in the Chambers of the Board of Supervisors of Contra Costa County administration Building, 1025 Escobar Street, Martinez, California, and any interested person was given an opportunity to protest the assessments and the Final Engineer's Report for the Countywide Landscaping District 1979-3 (LL-2), either in writing or orally, and it was determined that a majority protest has not been filed.

NOW, THEREFORE, BE IT RESOLVED that the CONTRA COSTA COUNTY BOARD OF SUPERVISORS:

- 3. Authorizes the levy of assessments for Fiscal Year 2021-22 for the Countywide Landscaping District 1979-3 (LL-2).
