Thank you for the opportunity to comment. Although I am vaccinated, I wanted to say that I am very much against the vaccine mandates, in particular for Health Clubs, for the following reasons:

- 1) Sufficient data has not been clearly communicated that would support the need for such a mandate in health clubs, where masks are currently required. And, the mandate came at a time when covid cases in our county were clearly declining.
 - a. For example, is there data showing spread in a health club where masks are worn, in a community like ours where there is a high vaccination rate?
 - b. Was the size/number of people in the health club been considered? (Our health club is quite large and uncrowded)
 - c. Was it considered that you may be further discouraging unvaccinated obese individuals at high risk of hospitalization & death from becoming healthier?
 - d. What will be the criteria for lifting this extreme mandate?

2) I believe the mandate undermines the public's belief in the efficacy of the vaccine.

- a. Prior to this mandate, I was a strong proponent of the vaccines & sought to encourage any unvaccinated friends/family to get the vaccine after analyzing the data & making a decision for themselves.
- b. After this mandate, I cannot in good conscience do this because it makes me suspect there may be data indicating vaccinated folks may be at a higher risk of hospitalization/death than previously communicating -- that is there is good reason for vaccinated, masked folks to fear unvaccinated masked folk. I don't think this is true, but the new mandate (without clearly communicated supporting data) has confused me.
- **3) I believe the mandate violates my medical privacy** (as HIPPA laws do not apply to health clubs and restaurants
- 4) I believe the mandate violates the right of individuals to make there on medical decisions, and further, it ignores probable natural immunity.
