Staff provided instruction for access to English live transcription (automated closed captioning) and live simultaneous Spanish interpretation and then conducted roll call. There were approximately 82 participants.

2. Public comment on any item under the jurisdiction of the Committee and not on this agenda (speakers may be limited to three minutes).

There were no public comments on items not on the agenda.

3. Staff recommends MXCAB receive the Record of Action for the June 9, 2021 meeting.

The Record of Action was accepted as presented.

4. RECEIVE presentations on the topic of Healthcare.

Mariana Moore introduced the topic for discussion. Dr. Ori Tzvieli, Public Health Medical Director and Deputy Health Officer, Contra Costa Health Services, Dr. Samir Shah, Chief Executive Officer and Chief Medical Officer, Contra Costa Regional Medical Center, Health Centers and Detention, Contra Costa Health Services, Gilbert Salinas, Chief Equity Officer, Contra Costa Health Services, Alvaro Fuentes, Executive Director, Community Clinic Consortium of Contra Costa and Solano, and Concepcion James, United Latino Voices presented on the healthcare needs in the County. Note that the presentation from United Latino Voices was not available until the meeting date due to a miscommunication, and is attached to these minutes for reference. The scheduled resident speaker was unavailable, Jose Rizo substituted to discuss his experiences. At the conclusion of the presentation, members of the MXCAB made comments and asked questions. The MXCAB took a break at 6:35 and then continued the discussion. At the conclusion of MXCAB member comments, members of the public were offered an opportunity to speak. Public comments were heard from Sylvia Castillo, Doreen Moreno, Rebecca Rozen, Paul (no last name given), Roxanne Carillo Garza, Vi Vo, Caitlyn Sly, Sarah Chodakewitz, Carolina Herrera, and Jaclyn LeSage.

5. Discuss/modify attached plan for presenters.

Mariana Moore introduced the topic for discussion and explained that it has been challenging to schedule speakers each week. MXCAB members provided feedback regarding their disappointment in the racial mix of speakers, in particular the under-representation of African American speakers. A question came up regarding MXCAB members being allowed to participate as presenters. Staff reminded the Committee that they had voted to disallow individual members from presenting (however, non-members are allowed to present from the member's organization). Following an in-depth discussion, Ms. Moore asked members to think about strategies and solutions on how to move forward in order to be prepared for the discussion next week. The updated list of suggested speakers is attached for reference. The group also supported a recommendation to ask presenters from the county and community-based organizations to focus their presentation remarks on describing their specific ideas and recommendations for the best use of Measure X funds for the issues on which they are presenting; more general background information on the department/organization and the issue/ecosystem can be presented in the written materials submitted by presenters for advance review by Advisory Board members.

During public comment, Cassie Blazer introduced the Life Learning Academy (<https://lifelearningacademysf.org>). From: Early Childhood Panel Organizations – First 5 Contra Costa, CSB/EHSD, HS, CocoKids, and Parent Voices

This memo provides follow-up information in response to a question posed to the panel presenting the Early Childhood Gaps, Needs and Funding Opportunities at the May 26 Measure X Community Advisory meeting. The question posed was about current strategies and efforts to ensure culturally sensitive and responsive services for young children. While the panel responded, we felt that supplemental information was necessary to comprehensively respond and inform Measure X CAB members about current efforts to build adult competencies and learning conditions to ensure cultural and developmentally appropriate practices.

Supporting children's home language and culture is critical to their social, emotional, and academic development of children; therefore, our partners throughout the county employ a variety of strategies at varying degrees to ensure the cultural needs of children and their families are taken into consideration. The following are a few important examples:

1. **Child care staff represent the families served in this county:** The Community Services Bureau (CSB) of the Employment and Human Services Department is the largest child care provider in the county, serving over 2,000 children each day through Head Start, Early Head Start, and State subsidized programs. The staff in their 16 centers represent the communities they serve by ensuring that at least one staff members in each classroom speaks the language of the majority of children in the classroom. In cases where that is not possible, staff work with the families to develop strategies to best support home language and culture.

Further, CocoKids as the resource and referral agency for the county, screens over 800 provider demographics in order to meet families' cultural and linguistic needs, so that when families choose the best childcare for their family, they have that information available to them.

2. **Capacity Building:** through professional development and capacity building, those working with young children develop a deeper understanding of the value of incorporating the child's home culture into their everyday curriculum.

Specialized trainings and workshops focusing on anti-bias curriculum, cultural humility, cultural responsiveness, and trauma informed practices are provided on-going, county-wide, through the Contra Costa County Quality Matters Initiative (QM). QM is an interagency partnership including the Contra Costa County Office of Education, CocoKids, First 5, and the three Community Colleges in the County, and other service providers. Through the QM Initiative, the collective agencies engage and support family child care providers, centers (public and private), and family, friends and neighbors by providing coaching, technical assistance, professional development and other supports with the end goal of improving the quality of learning settings for young children

Private and public programs, such as CSB, across the county implement Creative Curriculum, Program for Infant and Toddler Caregiving, the Teaching Pyramid, among others, that embed culturally and developmentally relevant practices into the everyday curriculum.

Additionally, county-wide initiatives funded through First 5 Contra Costa build provider capacity and knowledge for center-based and family child care providers. The following are two examples of First 5 sponsored culturally focused initiatives:

Dual Language Learner (DLL) Initiative – the DLL is comprised of three large strategies to support children’s home language and culture in early learning settings. Forty-three Contra Costa providers are enrolled in a two-unit dual language course that unpacks implicit bias, explores creative ways to learn from and with families, and discusses sound DLL assessment and bilingual language development with an emphasis on the critical relationship between home language and culture and children’s healthy sense of identity.

Ready Kids East County (RKEC) Initiative - RKEC takes a systems-wide approach to improve the chances that African American and Black young children in East Contra Costa County will be ready for kindergarten physically, academically, socially, and emotionally. The Initiative engages parents and community members in uncovering and addressing the complex interpersonal, institutional, community, social, environmental, and public policy factors that perpetuate inequities in school readiness for African American and Black children in East Contra Costa County. The Ready Kids East County Initiative plans to continue researching and reflecting on promising programming and curricula that center Black experiences, hosting learning communities, and connecting families to culturally relevant school readiness resources through Parent Cafés and experiences. Foundational is the core belief power should be redistributed to child

In closing, the panel wanted to provide supplemental information to this important question related to culture and race through this memo, as we feel proud of existing efforts that lift the cultures of our families and their children county-wide. We appreciate the opportunity to be able to further describe examples of programs, practices and initiatives that support the demographic diversity of the children and their families in Contra Costa.

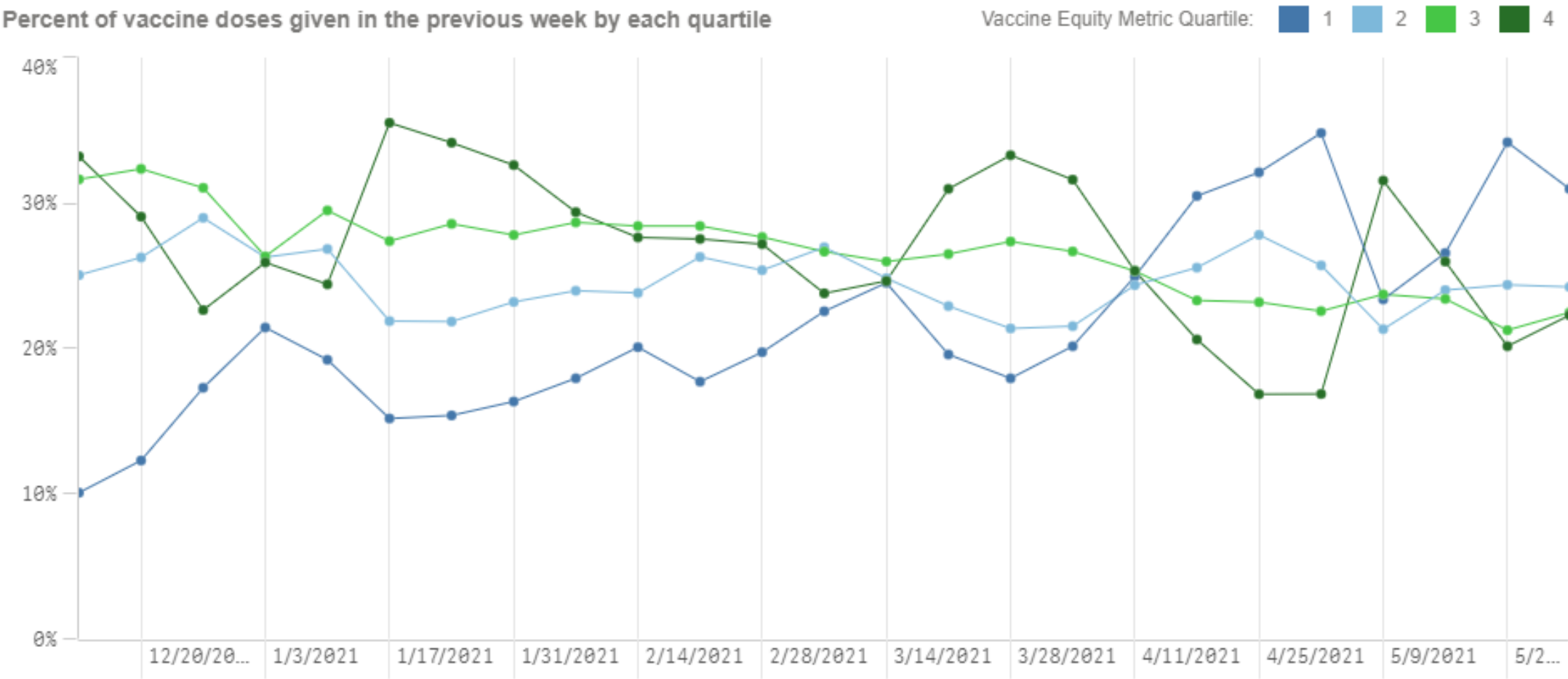

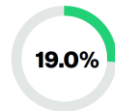

The Demographic and Economic Contributions of Immigrants¹ in the County²

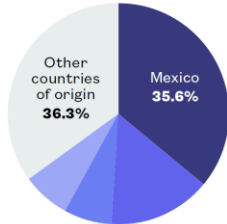

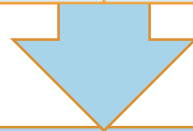


History of Contra Costa CARES

Launched in November 2015

Received \$1M funding from Contra Costa County, Kaiser Permanente, John Muir Health, & Sutter Delta Medical Center

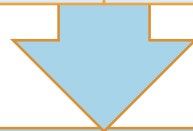
Initial goal: Provide coverage for a 12-month period to approximately 3,000 individuals



Expanded in April 2017

\$1.5M commitment from all partners

Increased total program capacity to 4,100 participants



A Unique Public-Private Partnership Pilot

\$7.5 committed through 2020: 100% of funding goes directly to patient services

Partnership has enabled the program to continue and is viewed as a model for coverage expansion in CA and beyond

CARES Services to Date

Partners

La Clínica de La Raza, LifeLong Medical Care, Brighter Beginnings

- Contra Costa Health Plan (CCHP) provides pro bono program administration and a 24/7 Nurse Advice Line
- Consortium provides ongoing data collection and evaluation, outreach and communications, and convenes program workgroups
- Hospitals provide additional support through grants, clinical volunteerism, and in-kind use of hospital facilities for specialty care services.

Primary Care

Provided to over 8,000 individuals with ~36,000 visits to date

- 98% are Latinx
- 93% are between the age of 26-65
- Over 50% of patients in the program are seen for chronic disease diagnosis/management

Enrollment

Annual enrollment has reached the program's cap of 4,100

- 65% of CARES enrollees have had one or more primary care visits
- 25% of CARES enrollees are frequent utilizers of the primary care services (6+ visits)

Main Takeaways:

- All participants interviewed reported that CARES had a positive impact on their lives
- Most participants reported having a difficult time accessing and following through with healthcare before enrolling in CARES due to financial barriers

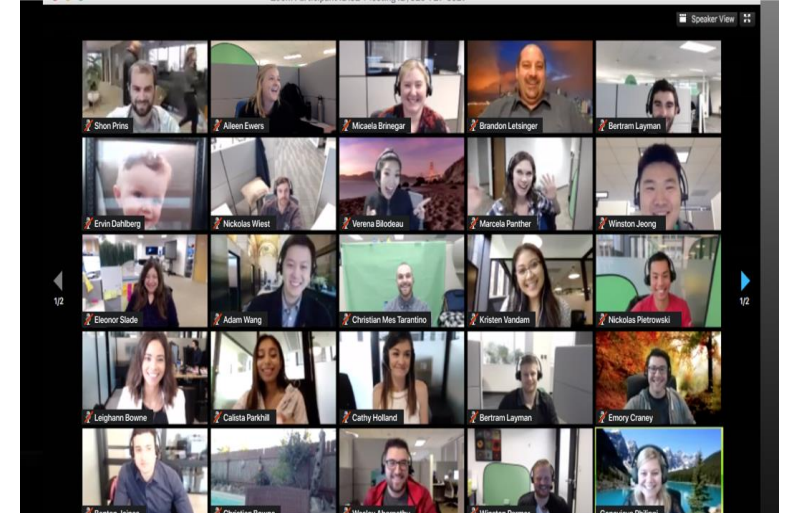

- ❑ Persistent barriers of access to care & proactive use of care before COVID and during COVID led to dire consequences



Key finding #2

- ❑ Lack of trust and relationships with key health & welfare governmental institutions detained community members from engaging in testing and vaccinations and early COVID care





Key finding #3

- ❑ Social conditions such as housing, food insecurity, lack of transportation, childcare were huge stressors before COVID and were exacerbated by COVID

Key Finding #4

- ❑ In the early stages of the pandemic there was a huge gap in community (boots on the ground) outreach & education which resulted in a COVID education/information gap for the most vulnerable.
