Description: Contra Costa County on June 8, 2021 contracted with Pavement Coatings Co. for the work. The work to be done generally consisted of applying an asphalt rubber chip seal covered with a type II slurry seal to various roads in the unincorporated areas of North Richmond, Castle Hill, Alamo, Clyde and Concord. Select roads in El Sobrante and in the North Richmond and Clyde area required a Mill and Overlay. Work also included surface preparation including, weed spray, edge grinding, pavement failure repair work, striping removal, adjusting survey monuments, and placement of thermoplastic striping and pavement markings, all in accordance with the plans, drawings, special provisions and/or specifications prepared by or for the Public Works Director and in accordance with the accepted bid proposal. The project was located countywide, with The Ohio Casualty Insurance Company, as surety, for work to be performed on the grounds of the County; and The Public Works Director reports that said work has been inspected and complies with the approved plans, special provisions and standard specifications and recommends its acceptance as complete as of May 10, 2022.
