To the Contra Costa County Board of Supervisors:

My name is Marissa Shaw, I live in Contra Costa County, and I have been a recipient of In Home Supportive Services for over 25 years. My IHSS attendants assist me with essential daily living tasks such as bathing, dressing, cooking, cleaning and shopping. Without this assistance, I would not be able to live independently. This care allows me to be a part of an active accessible community and enjoy life. The IHSS program helps me stay safe and live in the comfort of my own home and, by such, avoid being placed in a nursing home.

I am grateful for the IHSS program. However, over the last several years, it has been extremely difficult for me to attract and keep attendants due to the extremely low IHSS wages. The current rate in our county at \$16 per hour, which is not a living wage.

At the beginning of the pandemic, my weekend attendant resigned to work for an IHSS consumer in Alameda County because she could make more money there. Alameda County, our neighboring county, currently pays \$15. Traveling to different counties doesn't seem to bother attendants, as long as they receive a higher wage. In turn, this made it incredibly difficult for me to hire and retain a new weekend attendant.

Caregivers need a living wage and incremental increases every time the minimum wage goes up. I understand that money is tight within the county. However, an investment in IHSS wages means I, and others like me, can be part of our community, and it means better local jobs that can support the local economy. An investment in IHSS wages is an investment in Contra Costa County. The time for \$20/hour is now.

Does the county value people with disabilities and our desire to live independently? If so, please raise wages for attendant care workers so we can keep attendants from Contra Costa working within our county.
