Resolution No. 2023/240

In The Matter Of: Agreement Number OM-2223-07 between the California Department of Aging and Contra Costa County

WHEREAS: the Employment and Human Services Department’s Area Agency on Aging (AAA) administers the federal Older Americans Act, which funds Senior Nutrition, Family Caregiver Support, Disease Prevention and Health Promotion, and Supportive Services to address the needs and sustain the wellbeing and independence of residents age 60 years and over, persons with disabilities, and family caregivers in Contra Costa; and **WHEREAS:** the Older Californians Act was established in 1980 under AB 2975 to provide community based supports to augment the Older Americans Act and fill the gaps in services to support older individuals and disabled adults throughout the state; and **WHEREAS:** the State of California dedicated funding for the Modernizing Older Californians Act (MOCA) administered by the California Department of Aging and passed through to the AAAs for local implementation; and **WHEREAS:** through Agreement Number OM-2223-07, County enters into a contract with the California Department of Aging to receive MOCA funding to enable the Contra Costa County AAA to deliver Supportive Services that may include the following programs: Caregiver Respite, Linkages, Senior Companion, Alzheimer’s Day Care Resource Centers, Aging in Place, Senior Volunteer Development, Foster Grandparent, and Caregiver Support for People with Dementia/Alzheimer’s.

Now, Therefore, Be It Resolved: The Board of Supervisors approve and authorize the Employment and Human Services Director, or designee, to accept funding in an amount not to exceed \$1,561,649 from the California Department of Aging for Agreement Number OM-2223-07 to deliver Modernizing Older Americans Act Supportive Services in Contra Costa County for the period January 1, 2023 through March 31, 2026.
