**Resolution No. 2023/241**

**In The Matter Of:** California Department of Aging, Older Americans Act Funding.

**WHEREAS:** Congress passed the Older Americans Act (OAA) in 1965 in response to concerns about the lack of community services and supports for older persons. The Act has been reauthorized throughout the years and is today considered a major vehicle for delivering services to seniors, adults with disabilities, and family caregivers in the community; and **WHEREAS:** Contra Costa County’s Area Agency on Aging (AAA), a division in the Employment and Human Services Department (EHSD), implements, administers, and monitors OAA programs locally; and **WHEREAS:** The Title IIIC Senior Nutrition Program is a major program funded under the OAA, which includes serving meals onsite at congregate settings or delivering meals to homebound and frail individuals; and **WHEREAS:** Interagency Agreements with the following organizations enable the AAA to deliver Title IIIC-1 Congregate Meal Program directly to Contra Costa residents aged 60 and over and other eligible diners by offering hot, nutritious meals at Café Costa sites hosted by these agencies; and **WHEREAS:** As required in the OAA, program participants must be provided an opportunity to contribute back to the program; and **WHEREAS:** County expects to receive approximately \$150,000 in voluntary contributions from individuals receiving meals at these congregate dining sites; and **WHEREAS:** Per the OAA, these funds will be used to enhance the congregate meals programs; and **WHEREAS:** The following eleven (11) organizations will provide participants with an opportunity to donate to the program and then will remit those funds to EHSD: City of Antioch, Town of Danville, City of El Cerrito, City of Hercules, City of Martinez, City of Oakley, Pleasant Hill Recreation and Parks District, City of Richmond, Rossmoor – Golden Rain Foundation, City of San Pablo, and City of San Ramon.

**Now, Therefore, Be It Resolved:** the Board of Supervisors approve and authorize the Employment and Human Services Director, or designee, to execute Interagency Agreements with Cities and a nonprofit agency to deliver the Older Americans Act Title IIIC-1 Congregate Meal Program by hosting and coordinating the Area Agency on Aging’s Café Costa meal sites for the period July 1, 2023 through June 30, 2024 and for County to accept voluntary contributions from program participants.
