### **RECOMMENDATION(S):**

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Novation Interagency Agreement #74–371–4 with Mt. Diablo Unified School District, a government agency, in an amount not to exceed \$3,801,511, to provide school-based mental health services to Seriously Emotionally Disturbed (SED) students in the Mt. Diablo Unified School District for the period from July 1, 2012 through June 30, 2013. This contract includes a six-month automatic extension through December 31, 2012 in an amount not to exceed \$1,900,756.

### **FISCAL IMPACT:**

This Contract is funded 34% by Federal Financial Participation, 34% by Mental Health Realignment, 32% by Mt. Diablo Unified School District. (No rate increase)

## **BACKGROUND:**

This Contract meets the social needs of County's population by providing school and community based mental health services, including assessments; individual, group and family therapy; medication support; case management; outreach; and crisis intervention services

# BACKGROUND: (CONT'D)

On January 10, 2012, the Board of Supervisors approved Novation Interagency Agreement #74–371-3 with Mt. Diablo Unified School District, for the period from July 1, 2011 through June 30, 2012, which included a six-month automatic extension through December 31, 2012, for the provision of school-based mental health services to SED students.

Approval of Novation Interagency Agreement #74–371–4 replaces the six-month automatic extension under the prior Contract and allows the Agency to continue providing services through June 30, 2013.

### CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, SED children will have reduced access to treatment services and may require placement at higher level of care, including hospitalization or residential care in Mt. Diablo Unified School District.

## CHILDREN'S IMPACT STATEMENT:

This school-based program supports the following Board of Supervisors' community outcomes: "Children Ready For and Succeeding in School"; "Families that are Safe, Stable, and Nurturing"; and "Communities that are Safe and Provide a High Quality of Life for Children and Families".
