Subject: Novation Contract #74-399-2 with Contra Costa Interfaith Transitional Housing, Inc.

RECOMMENDATION(S):

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Novation Contract #74-399-2 with Contra Costa Interfaith Transitional Housing, Inc., a non-profit corporation, in an amount not to exceed \$146,000, to provide community-based mental health services for Seriously Emotionally Disturbed (SED) youth, for the period from July 1, 2012 through June 30, 2013. This Contract includes a six-month automatic extension through December 31, 2013, in an amount not to exceed \$73,000.

FISCAL IMPACT:

This Contract is funded 50% by Federal Financial Participation and 50% Mental Health Realignment. (No rate increase)

BACKGROUND:

This Contract meets the social needs of County's population by providing community-based mental health services, including individual, group and family therapy; case management; and crisis intervention services for SED youth and their families at the Garden Park Apartments.

On December 6, 2011, the Board of Supervisors approved Contract #74-399-1 with Contra Costa Interfaith Transitional Housing,

BACKGROUND: (CONT'D)

Inc., for the period from July 1, 2011 through June 30, 2012, which included a six-month automatic extension through December 31, 2012, for the provision of community-based mental health services.

Approval of Novation Contract #74-399-2 replaces the automatic extension under the prior Contract and allows the Contractor to continue providing services through June 30, 2013.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, emotionally disturbed youth will have reduced access to the mental health services provided by Contractor, including individual, group and family therapy; case management; and crisis intervention services.

CHILDREN'S IMPACT STATEMENT:

This program supports the following Board of Supervisors' community outcomes: "Children Ready For and Succeeding in School"; "Families that are Safe, Stable, and Nurturing"; and "Communities that are Safe and Provide a High Quality of Life for Children and Families".
