Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Contract #23-513-2 with Optuminsight, Inc, a corporation, in an amount not to exceed \$800,000, to provide professional consultation and technical assistant to Department's Information Systems Director with regard to the EPIC Project, for the period from January 1, 2013 through December 31, 2013.

## **FISCAL IMPACT:**

This Contract is funded 100% by Medicare & Medicaid Electronic Health Records Incentive Program of the American Recovery & Reimbursement Act (ARRA) and the Delivery System Reform and Incentive Poop (DSRIP) funding. (No rate increase)
