Subject: Contract #74-456 with Contra Costa ARC

## **RECOMMENDATION(S):**

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Contract #74-456 with Contra Costa ARC, a non-profit corporation, in an amount not to exceed \$366,667, to provide mental health services to children and families in a substance abuse treatment setting for the period from November 1, 2012 through June 30, 2013.

## **FISCAL IMPACT:**

This Contract is funded 45% by Federal Financial Participation, 45% Mental Health Realignment and 10% First 5 Contra Costa Children's and Families Commission funds.

## **BACKGROUND:**

This Contract meets the social needs of County's population by providing mental health services to children, ages 0-5, their mothers and families who are enrolled in a substance abuse treatment program. Contractor's programming and services will focus on strengthening and maintaining mother-child relationships as a key factor in health early childhood development.
