Subject: Novation Contract #74-375-4 with Rainbow Community Center of Contra Costa County

RECOMMENDATION(S):

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Novation Contract #74-375-4 with Rainbow Community Center of Contra Costa County, a non-profit corporation, in an amount not to exceed \$220,507, to provide Mental Health Services Act (MHSA) Prevention and Early Intervention (PEI) services for the period from July 1, 2013 through June 30, 2014. This Contract includes a six-month automatic extension through December 31, 2014, in an amount not to exceed \$110,253.

FISCAL IMPACT:

This Contract is funded 100% by Proposition 63/MHSA. No County funds are required. (No rate increase)

BACKGROUND:

This Contract meets the social needs of County's population by providing a community-based social support program designed to decrease isolation, depression and suicidal ideation among members of the Lesbian, Gay, Bisexual, Transgender and Questioning (LGBTQ) community residing in Contra Costa County.

BACKGROUND: (CONT'D)

approved Contract #74–375-3 with Rainbow Community Center of Contra Costa County, for the period from July 1, 2012 through June 30, 2013, which included a six-month automatic extension through December 31, 2013, for the provision of MHSA PEI services.

Approval of Novation Contract #74–375–4 replaces the automatic extension under the prior Contract, and allows Contractor to continue providing services through June 30, 2014.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, Contractor will not provide outreach and community engagement events, support groups, in-services, and counseling to the LGBTQ community and their families.

CHILDREN'S IMPACT STATEMENT:
