RECOMMENDATION(S):

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Contract #26-244-11 with Sodexo Laundry Services, Inc., a corporation, in an amount not to exceed \$2,280,000, for the provision of linen rental and laundering services for the Contra Costa Regional Medical Center and Health Centers, for the period from October 1, 2013 through September 30, 2016.

FISCAL IMPACT:

100% Funding is included in the Enterprise Fund I Budget. (Rate increase)

BACKGROUND:

Linen rental and laundering services for Contra Costa Regional Medical Center and Contra Costa Health Centers have been provided under contract since 1984. On October 12, 2010, the Board of Supervisors approved Contract #26-244-8 (as amended by Contract Amendment Agreement #26-244-9 and #26-244-10) with Sodexo Laundry Services, Inc., for the period from October 1, 2010 through September 30, 2013, for the provision of linen
