BACKGROUND: (CONT'D)

Amend the Maximum Reimbursable Amount (MRA) from \$6,889,491 to \$8,364,928

- Amend the Maximum Rate per child day of enrollment from \$34.38 to \$36.10
- Amend the corresponding Child Days of Enrollment (CDE), through which reimbursement rates are set, from 200,683 CDEs to 231,715 CDEs

CONSEQUENCE OF NEGATIVE ACTION:

If not approved, County will not receive funding to operate these childcare programs.
