### **BACKGROUND:**

On March 25, 2014 the Board of Supervisors approved Contract #26-759 (as amended by Amendment Agreement #26-759-1) with Medical Anesthesia Consultants Medical Group, Inc. for the provision of anesthesia staffing coverage at CCRMC including consultation, training, medical procedures, and on-call coverage for General and Obstetrics Units for the period from March 1, 2014 through February 28, 2015. Approval of Contract #26-759-2 will allow Contractor to continue to provide anesthesia services at CCRMC through February 28, 2018.
