BACKGROUND:

On March 10, 2015, the Board of Supervisors approved Contract #26-792 with Edward Tang, M.D. for the provision of orthopedic services at Contra Costa Regional Medical Center (CCRMC), for the period from March 1, 2015 through February 29, 2016. Due to a mutual mistake the consultant fee was not included and Resource-based relative value scale (RBRVS) Surgical fee was incorrect.
