Subject: Amendment #26-590-16 with The Greeley Company, Inc.

RECOMMENDATION(S):

Approve and authorize the Health Services Director, or his designee to execute on behalf of the County, Amendment Agreement #26-590-16 with The Greeley Company, Inc., a corporation, effective May 1, 2015, to amend Contract #26-590-11 (as amended by Contract amendment/extensions #26-590-12, #26-590-13, #26-590-14, and 15), to increase the payment limit by \$65,000 from \$697,800 to a new total payment limit of \$762,800, with no change in the original term of September 1, 2013 through December 31, 2015.

On January 14, 2014, the County Administrator approved and Purchasing Services Manager executed Contract #26-590-11 (as amended by Contract Amendment/Extension Agreements #26-590-12, #26-590-13 #26-590-14, and #26-590-15) with The Greeley Company, Inc., for the period from September 1, 2013 through December 31, 2015, to provide consulting services at Contra Costa Regional Medical Center and Contra Costa Health Centers and

BACKGROUND: (CONT'D)
