### **BACKGROUND:**

Taxicab services were originally provided, and paid for, under Purchase Order and has been utilized when a clinical condition could be adversely affected by lack of transportation for needed medical care, including but not limited to, physical disabilities which make it unsafe for patients to travel on public transportation, patients that have a verifiable seizure disorder, or patients that receive mediation which has or could impair the mobility or coordination of the patient.
