Subject: Contract #72-024-3 with Quality Vending Systems, Inc.

RECOMMENDATION(S):

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Contract #72-024-3 with Quality Vending Systems, Inc., a corporation, to furnish healthy vending machine services at specified Contra Costa Health Services (CCHS) locations, for the period from October 1, 2015 through September 30, 2018.

FISCAL IMPACT:

County will receive 20% commission for drinks and snack machines and 8% for fresh food machines based on total gross vending sales. There is no general fund impact.

BACKGROUND:

Excess bodyweight and obesity are leading risk factors for a range of health problems that include: heart disease, type 2 diabetes, some cancers, high blood pressure, stroke, liver disease, respiratory problems and other conditions. Since 2010, CCHS has implemented a 100% Healthy Vending Policy to support the health of members of the public and staff who use the County's Health Centers and Regional Medical Center.

On November 12, 2013, the Board of Supervisors approved Contract #72-024-1 (as
