## **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Employment and Human Services Director, or designee, to execute a contract amendment with FamiliesFirst, Inc., dba EMQ FamiliesFirst, effective April 15, 2016, to increase the payment limit by \$75,000 to a new payment limit of \$831,125, for additional initial emergency financial support to caregivers raising a relative's child while awaiting home approval for the period July 1, 2015 through June 30, 2016. #### **BACKGROUND:**

FamiliesFirst, Inc. was selected from a competitive procurement, Request for Proposal (RFP #1141 in June 2015 to provide Family Enhancement Collaborative (FEC) services to the Children and Family Services (CFS) Bureau. Services under the FEC included shared family care, kinship, and family preservation. The Kinship Support Services Program provides multiple support services to help relative caregivers and children remain safe, healthy, and nurturing. Kinship services include site-based mentoring services where
