## **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County, Contract Amendment Agreement #26-515-13 with Virtual Radiologic Professionals of California, a corporation, effective March 1, 2016, to amend Contract #26-515-11 (as amended by Amendment Agreement #26-515-12), to increase the payment limit by \$84,500, from \$400,000 to a new payment limit of \$484,500, with no change in the original term of August 1, 2014 through July 31, 2016.

On September 23, 2014, the Board of Supervisors approved Contract #26-515-11 (as amended by Amendment Agreement #26-515-12) with Virtual Radiologic Professionals of California, for the provision of teleradiology services at Contra Costa Regional Medical Center and Health Centers, for the period from August 1, 2014 through July 31, 2016. At the time of negotiations, the payment limit was based on target levels of utilization; however, the utilization during the term
