#### **RECOMMENDATION(S):**

Adopt Position Adjustment Resolution No. 22062 to add one permanent full-time Substance Abuse Program Manager (VHGE) at salary level ZA5-1750 (\$6,547 - \$7,958) in the Health Services Department. (Represented)

### FISCAL IMPACT:

Upon approval, there is an annual cost of approximately \$154,542, which includes an estimated pension cost of \$33,903. The cost will be entirely offset 100% with budgeted Third Party funding.

### **BACKGROUND:**

The Health Services Department is requesting to add a Substance Abuse Program Manager for its Youth Services Alcohol and Other Drugs Program. A full time Substance Abuse Program Manager is needed to provide administrative and clinical oversight to ensure the services being provided are in compliance to both Federal and State regulations for all youth Substance Use Disorder (SUD) services in Contra Costa County. The primary responsibility includes program evaluations, need assessments, establish relationships with strategic
