## **BACKGROUND:**

Public Works Facilities Services is responsible for electronic system (alarm) monitoring in county buildings. Denalect Inc., was identified as the County's standard for this type of monitoring, and all alarmed buildings now have Denalect equipment installed in them. Facilities Services is in the process of upgrading the equipment in each monitored facility. This request is to allow payment of these costs.
