RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or his designee, to execute on behalf of the County, Contract Extension Agreement #26-398-18 (VA261-13-S-0217) with the U.S. Department of Veterans Affairs Northern California Health Care System (VANCHCS) to provide dermatology services for patients referred for treatment by Contra Costa Regional Medical Center physicians, to extend the term from August 31, 2017 through August 31, 2018.

FISCAL IMPACT:

There is no change in the contract payment limit of \$320,000. This Contract is funded 100% Hospital Enterprise I Fund.

BACKGROUND:

For many years, the County and U.S. Department of Veterans Affairs have maintained a mutual sharing agreement, which has made available to the County specialized medical services not otherwise available due to lack of resources, equipment, and personnel. These services included specialized laboratory testing, radiology services, nuclear medicine studies, computed tomography (CT) scans, magnetic resonance images (MRIs),
