# BACKGROUND: (CONT'D)

Employment and Human Services Department, Zero Tolerance for Domestic Violence, was notified by the Department of Justice, Office of Violence Against Women of a supplemental grant award in the amount of \$1,200,000.

The Department of Justice, Office of Violence Against Women, was created to build capacity of local jurisdictions to improve identification of and provision of services for domestic violence victims who are at risk of lethality and to improve the monitoring of high risk offenders. The additional funding will continue and expand the Lethality Assessment Program, County participation in the Demonstration Initiative, and the ongoing evaluation process.
