RECOMMENDATION(S):

Approve and authorize the Health Services Director, or his designee, to execute, on behalf of the County, Novation Interagency Agreement #74-371-9 with Mt. Diablo Unified School District in an amount not to exceed \$3,616,637, to provide school-based mental health services to Seriously Emotionally Disturbed (SED) students in the Mt. Diablo Unified School District for the period from July 1, 2017 through June 30, 2018, which includes a six-month automatic extension through December 31, 2018 in an amount not to exceed \$1,673,921.

FISCAL IMPACT:

This contract is funded 46% by Federal Medi-Cal, 46% by Mental Health Realignment, and 8% by the Mt. Diablo Unified School District. (Rate increase)

BACKGROUND:

This contract meets the social needs of the County's population by providing school and community based mental health services, including: assessments; individual, group and family therapy; medication support; case management; outreach; and crisis intervention services for children at Sunrise Elementary School and Olympic/Alliance High School, and

their families. On July 7, 2016, the Board of Supervisors approved Interagency Agreement #74-371-8 with Mt. Diablo Unified School District, for the period from July 1, 2016 through June 30, 2017, which included a six-month automatic extension through December 31, 2017, for the provision of school-based mental health services to SED students. Approval of Novation Interagency Agreement #74-371-9 will replace the automatic extension and will allow the agency to continue providing services through June 30, 2018.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, SED children will have reduced access to treatment services and may require placement at higher level of care, including hospitalization or residential care in the Mt. Diablo Unified School District.

CHILDREN'S IMPACT STATEMENT:

This school-based program supports the following Board of Supervisors' community outcomes: "Children Ready For and Succeeding in School"; "Families that are Safe, Stable, and Nurturing"; and "Communities that are Safe and Provide a High Quality of Life for Children and Families". Expected program outcomes include an increase in positive social and emotional development as measured by the Child and Adolescent Functional Assessment Scale (CAFAS).
