RECOMMENDATION(S):

APPROVE and AUTHORIZE the Employment and Human Services Director, or designee, on behalf of the Family and Children's Trust Committee, to execute a contract containing modified indemnification language with the YMCA of the Eat Bay in an amount not to exceed \$80,000 to provide Attachment, Self Regulation and Competency Project services for the period July 1, 2018 through June 30, 2019.

FISCAL IMPACT:

This contract is funded 100% by State from Child Abuse Prevention, Intervention and Treatment funding (CAPIT).

BACKGROUND:

The Attachment, Self Regulation and Competency Project will provide mental health services, including Trauma Focused Cognitive Behavioral Therapy (TF-CBT) to elementary school students in San Pablo who do not qualify for Medi-Cal. Through the provision of direct services and advocacy in English and Spanish, caregivers will receive support and information to help them with positive nurturing parenting; provide students with trauma informed counseling to improve resiliency and emotional and behavioral health; reduce
