### **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Employment and Human Services Director, or designee, to execute a contract with A Step Forward Child Abuse Treatment and Training Programs, a Marriage, Family and Child Counseling Corporation, a for-profit corporation, in an amount not to exceed \$200,000 to provide menal health services to non-Medi-Cal eligible clients for the period August 1, 2018 through July 31, 2020.

#### FISCAL IMPACT:

The contract is funded 70% with State revenue and 30% with County General Fund.

#### **BACKGROUND:**

A Step Forward Child Abuse Treatment and Training Programs, a Marriage, Family and Child Counseling Corporation provides mental health services to non-Medi-Cal eligible clients of Employment and Human Services Department (EHSD), as well as non-Medi-Cal reimbursable services determined appropriate and authorized by the EHSD Children and Family Services Bureau (CFS) for Medi-Cal eligible clients. The contract includes compliance with certification requirements, maintaining and compliance with contractor's County mental health services contract, compliance with reporting requirements,
