This cost is to be funded through Public Works Facilities Services budget. (100% General Fund)


#### **BACKGROUND:**

## BACKGROUND: (CONT'D)

> playgrounds at select County Head Start facilities. GameTime will be able to provide services for both of these types of work at rates made available through the U.S. Communities cooperative purchasing program national solicitation. California Government Code Section 25358 authorizes the County to contract for maintenance, care and upkeep of County Facilities. Under the contract, GameTime is entitled to rate increases on each anniversary of the effective date of this contract by a factor equal to the rate of increase in the Consumer Price Index for the San Francisco – Oakland area as published by the Bureau of Labor Statistics for the year immediately preceding, plus 2%. Facilities Services is requesting a contract with PlayCore to be approved for a period covering the next three years.

# **CONSEQUENCE OF NEGATIVE ACTION:**

If this contract is not approved, playground repairs will be discontinued.
