Subject: Novation Contract #74-543-1 with YWCA of Contra Costa/Sacramento

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County, Novation Contract #74-543-1 with YWCA of Contra Costa/Sacramento, a non-profit corporation, in an amount not to exceed \$534,852 to provide mental health services for Seriously Emotionally Disturbed (SED) children and adolescents for the period from July 1, 2018 through June 30, 2019, which includes a six-month automatic extension through December 31, 2019, in an amount not to exceed \$267,426.

FISCAL IMPACT:

This contract is funded 50% by Federal Medi-Cal and 50% by Mental Health Realignment funds. (Rate increase)

BACKGROUND:

This contract meets the social needs of County's population by providing mental health services to adolescents with emotional and behavioral problems to improve school performance, reduce unsafe behavioral practices, and reduce the need for out-of-home placements.

BACKGROUND: (CONT'D)

Contra Costa/Sacramento to provide mental health services for SED children and adolescents for the period April 1, 2017 through June 30, 2018, including a six-month automatic extension through December 31, 2018.

Approval of Novation Contract #74-543-1 replaces the automatic extension under the prior contract and allows the contractor to continue to provide mental health services through June 30, 2019.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, SED children and adolescents will not have access to mental health services provided by the contractor.

CHILDREN'S IMPACT STATEMENT:
