## **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Employment and Human Services Director, or designee, to execute a contract with KinderCare Learning Centers LLC in an amount not to exceed \$475,522 to provide Early Head Start Childcare Partnership and State General Childcare program services for the period July 1, 2018 through June 30, 2019.

#### **FISCAL IMPACT:**

This contract is 53.8% funded by federal grant funds from the Administration for Children and Families (Head Start Program). The remaining 46.2% of the contract is State funded through the California Department of Education. There is no County match requirement. [CFDA 93.600]

## **BACKGROUND:**

Contra Costa County receives funds from the U.S. Department of Health and Human Services, Administration for Children and Families (ACF) to provide Head Start and Early Head Start program services to program eligible County residents. The Employment and Human Services Department,

# **BACKGROUND: (CONT'D)**

in turn, contracts with a number of community-based organizations to provide a wider distribution of services. This contract provides funding for 32 childcare program slot for children ages 0 to 3 years. It also provides \$59,100 in program improvement funding and funding for 16 childcare program slots in the State General Childcare program.

If not approved, the County will not be able to fund additional childcare slots and start up funds for it's community based agency partner, KinderCare Learning Centers LLC.
