### **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the County Probation Officer, or designee, to execute a contract with the California Department of Corrections and Rehabilitation, in an amount not to exceed \$149,856 beginning upon Board and State approval through June 30, 2021 for diagnostic and treatment services to youth referred from Juvenile Count in Contra Costa County and in custody at Department of Juvenile Justice (DJJ) facilities.

#### FISCAL IMPACT:

\$149,856, 100% General Fund

### **BACKGROUND:**

The California Department of Corrections and Rehabilitation provides diagnostic studies, treatment services and temporary detention for case referrals from Juvenile Courts for a period not to exceed ninety (90) days. The cost of this treatment is borne by the County in which the Court is situated. The Director of the facility reports to the court its diagnosis and recommendations concerning the person within the ninety (90) days.
