RECOMMENDATION(S):

APPROVE and AUTHORIZE the Employment and Human Services Director, or designee, to execute a contract with CocoKids, Inc., a non-profit corporation, in an amount not to exceed \$674,298, to provide Emergency Child Care Bridge Program for Foster Children services for the period of July 1, 2019 through June 30, 2020.

FISCAL IMPACT:

The cost of the contract is covered 81% by State funding (State Capped Allocation) and 19% by Federal Title IV-E funding.

BACKGROUND:

The lack of access to child care for potential eligible families seeking to take in a foster child is one of the top barriers to placing young foster children with families. The passage of Senate Bill (SB) 89 established the Emergency Child Care Bridge Program for Foster Children (Bridge Program). The contractor provides Bridge Program services that include a six-month payment (or voucher) for child care, as well as assistance from child care

The purpose of this program is to increase the number of foster children successfully placed in home-based family care, increase capacity of child care programs to meet the needs of foster children in their care, and maximize funding to support the child care needs of eligible families.

CONSEQUENCE OF NEGATIVE ACTION:

Availability of ideal placement of foster children with eligible families may be limited.
