The County's Bicycle and Pedestrian Safety Project goal is to provide

BACKGROUND: (CONT'D)

safe walking and biking education by providing classroom education; assemblies, information tables, and school events; bicycle helmet distribution; educational materials; and facilitated bicycling and walking events. These funds will allow the County to provide 8 bicycle and pedestrian safety presentations to reach at least 150 third and fourth-grade students; 4 bicycle and pedestrian safety assemblies to reach at least 250 middle school students; 6 information tables to reach at least 300 middle school students; 5 campus events to reach at least 200 middle school students; 2-4 safe bicycling or walking events with school and community partners; and provide approximately 500 helmets to children of low-income families in Contra Costa County.

Approval of the Grant Agreement #28-640-9 will allow the County to provide bicycle and pedestrian education services through June 30, 2020.

CONSEQUENCE OF NEGATIVE ACTION:

If this grant agreement is not accepted, the additional bicycle and pedestrian safety projects would be delayed or not carried out.
