### **RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Interagency Agreement #29-602-3 with The Tides Center, a non-profit corporation, to pay County an amount not to exceed \$291,652, to provide mental health and crisis intervention services for the School Engagement Program, for the period from July 1, 2019 through June 30, 2020.

#### **FISCAL IMPACT:**

Approval of this Interagency Agreement will result in payment to the County not to exceed \$291,652 from The Tides Center. No County match required.

## **BACKGROUND:**

On September 11, 2018, the Board of Supervisors approved Interagency Agreement #29-602-2 with The Tides Center for the period from July 1, 2018 through June 30, 2019, to collaborate to provide mental health services and crisis intervention to students enrolled in Contra Costa County schools and their families through the School Engagement Program.

### BACKGROUND: (CONT'D)

Health Services Department subcontracted with Lincoln Child Center to provide mental health services and crisis intervention to students who have been referred to the School Engagement Program through the State of California Court Parent Truancy Program, the County's District Attorneys' Office and the Contra Costa County Office of Education.

Approval of Interagency Agreement #29-602-3 will allow The Tides Center to continue to pay the County for the provision of mental health services and crisis intervention for students and their families enrolled in Contra Costa County schools, through June 30, 2020.

# **CONSEQUENCE OF NEGATIVE ACTION:**

If this agreement is not approved, the County will not be able to provide these mental health services and crisis intervention under the School Engagement Program to students and families in the Contra Costa County.
