Subject: Contract #25-078-2 with Shelter, Inc. of Contra Costa County

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #25-078-2 with Shelter, Inc. of Contra Costa County, a non-profit corporation, in an amount not to exceed \$2,281,486, to provide housing assistance to Seriously and Persistently Mentally Ill (SPMI) youth and adults for the period from July 1, 2019 through June 30, 2020.

FISCAL IMPACT:

This Contract is funded 100% by Mental Health Services Act. (No rate increase)

BACKGROUND:

This Contract meets the social needs of the County's population in that it provides support services to County residents that are homeless and have a diagnosis of mental illness or a dual-diagnosis of mental illness and substance abuse, and are receiving services of Contra Costa County Mental Health or other approved referral agencies.

On July 20, 2018, the Board of Supervisors approved Contract #25-078-1 with Shelter, Inc. of Contra Costa County for the provision of housing assistance to SPMI youth and adults,

BACKGROUND: (CONT'D)

Approval of Contract #25-078-2 will allow Contractor to continue to provide housing assistance through June 30, 2020.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, SPMI youth and adults will not receive the housing assistance they need, putting them at risk for remaining homeless and requiring higher levels of care for mental illness and/or substance abuse.

CHILDREN'S IMPACT STATEMENT:

This program supports two of the Board of Supervisors' five community outcomes: "Families that are Safe, Stable, and Nurturing"; and "Communities that are Safe and Provide a High Quality of Life for Children and Families". Expected program outcomes include an increase in positive social and emotional development as measured by the Child and Adolescent Functional Assessment Scale (CAFAS).
