Subject: Contract #26-306-31 with Per Diem Staffing Systems, Inc.

**RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #26-306-31 with Per Diem Staffing Systems, Inc., a corporation, in an amount not to exceed \$1,200,000 to provide temporary respiratory therapists, nursing, and other medical classifications at Contra Costa Regional Medical Center (CCRMC) and Contra Costa Health Centers for the period July 1, 2019 through June 30, 2020.

**FISCAL IMPACT:**

This contract is funded entirely by Hospital Enterprise Fund I. (Rate increase)

**BACKGROUND:**

On September 11, 2018, the Board of Supervisors approved Contract #26-306-29 (as amendment by Extension Agreement #26-306-30) with Per Diem Staffing Systems, Inc., to provide temporary respiratory therapists, nursing and other categories of medical services to cover employee sick leaves, vacations and workers compensation leaves, at CCRMC and Contra Costa Health Centers for the period July 1, 2018 through June 30, 2019.
