Subject: Contract with AGFA Healthcare Corporation for Circles of Care Maintenance Renewal

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director or designee to execute, on behalf of the County a software and hardware support agreement with AGFA Healthcare Corporation in an amount not to exceed \$250,725 for Circles of Care Clinical hardware and software maintenance for the period of April 1, 2019 through March 31, 2020.

FISCAL IMPACT:

This work is entirely funded by the Hospital Enterprise Fund I and is included in the budget.

BACKGROUND:

Health Services uses the AGFA Circles of Care software for necessary service and maintenance support to the cardiology and diagnostic imaging departments' electronic imaging systems at Contra Costa Regional Medical Center (CCRMC) and Health Centers. Currently CCRMC and the Health Centers utilize the AGFA IMPAX system for all diagnostic and cardiology images. The system provides high quality imaging for patients and continuous image availability to the caregivers. Sustaining this availability requires a maintenance and support agreement with the vendor. Without this renewal, CCRMC and Health Centers will no longer receive critical software updates or vendor support in the
