Subject: Contract #72-086-6 with Bright Path Therapists, Inc.

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #72-086-6 with Bright Path Therapists, Inc., a corporation, in an amount not to exceed \$250,000, to provide temporary medically necessary occupational therapy (OT) and physical therapy (PT) staffing services to children eligible for the California Children Services Medical Therapy Program for the period July 1, 2019 through June 30, 2020.

FISCAL IMPACT:

This Contract is funded by 50% State California Children's Services and 50% County funds. (No rate increase)

BACKGROUND:

In August 2018, the County Administrator approved and Purchasing Services Manager executed Contract #72-086-4 (as amended by Contract Amendment #72-086-5) to provide temporary medically necessary occupational therapy and physical therapy services to children eligible for the California Children's Services Medical Therapy for the period from July 1, 2018 through June 30, 2019.
