Subject: Novation Contract #28-705-17 with the City of Hercules

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Novation Contract #28-705-17, which contains mutual indemnification, with the City of Hercules, a government agency, to provide congregate meal services for County’s Senior Nutrition Program, for the period from July 1, 2019 through June 30, 2020. This Contract includes a three-month automatic extension through September 30, 2020.

FISCAL IMPACT:

The City of Hercules (Agency) will pay County the voluntary contributions it receives from participating seniors, after it has paid its authorized expenses. Agency will fund all activities related to this contract, with no County funds required.

BACKGROUND:

This Contract meets the social needs of County’s population by providing an average of 35 congregate meals per day, five days per week for senior citizens at the Hercules Senior Center. While the County provides the meals to be distributed, food service equipment and supplies, nutrition education, food service monitoring, and overall program administration,

BACKGROUND: (CONT'D)

On June 26, 2018, the Board of Supervisors approved Novation Contract #28-705-16 with the City of Hercules for the provision of congregate meal services for County's Senior Nutrition Program, for the period from July 1, 2018 through June 30, 2019, which included a three-month automatic extension through September 30, 2019.

Approval of Novation Contract #28-705-17 replaces the automatic extension under the prior Contract and allows Agency to continue providing services through June 30, 2020. This Contract includes mutual indemnification.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, senior citizens who depend on County's Senior Nutrition Program will not receive meals at Contractor's facility.
