### **BACKGROUND:**

Public Works Facilities Services is responsible for grounds maintenance of all County properties. An important aspect of this is tree maintenance and trimming. The contractor will provide tree maintenance, trimming and complete removal, as needed. The Contractor also has the personnel, equipment and training to trim trees near power lines and provide any necessary traffic control.
