# **BACKGROUND:**

The Alamo Municipal Advisory Council (Alamo MAC) presents free summer concerts and movie nights at Livorna Park. A recreation sub-committee of the Alamo MAC chooses the movies and the bands each year. Pending Covid-19 pandemic restrictions at that time, the "2021 Alamo Summer Concert Series" will take place on July July 2nd, 16th, and 30th at 6:30 p.m., and the "2021 Alamo Movie Under the Stars" will take place on July 9th and 23rd at 8:45 p.m. CSA R-7 parks and recreation funds are used to present these popular community events. On July 7, 2020, the Alamo MAC recommended that up to \$60,900 be allocated to the summer concert series and movie nights at Livorna Park for the 2020-21
