APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #74-592-3 with Jennifer Lee Miles, M.D., an individual, in an amount not to exceed \$319,488, to provide outpatient psychiatric care services to children and adolescents, for the period from April 1, 2021 through March 31, 2022.

FISCAL IMPACT:

Approval of this contract will result in budgeted expenditures of up to \$319,488 and will be funded by 50% Federal Medi-Cal (\$159,744) and 50% Mental Health Realignment (\$159,744) revenues.

BACKGROUND:

Behavioral Health has been contracting with Jennifer Lee Miles, M.D. since April 2019 for her expertise in providing outpatient psychiatric care to children and adolescents. In March 2020, County Administrator approved and Purchasing Services Manager executed Contract #74-592-1 with Jennifer Lee Miles, M.D., to provide outpatient psychiatric care to children and adolescents for the period from April 1, 2020 through March 31, 2021 in the amount of \$199,680. On February 2, 2021, the Board of Supervisors approved Amendment
