Subject: Contract #77-062-5 with Medic Shuttle, LLC

**RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Service Director, or designee, to execute on behalf of the County Contract #77-062-5 with Medic Shuttle, LLC, a limited liability company, in an amount not to exceed \$1,800,000, to provide non-emergency medical transportation/paratransit services for Contra Costa Health Plan (CCHP) members, for the period April 1, 2021 through March 31, 2024.

**FISCAL IMPACT:**

This contract will result in contractual service expenditures of up to \$1,800,000 over a three-year period and will be funded 100% by CCHP Enterprise Fund II.

**BACKGROUND:**

CCHP has an obligation to provide certain specialized health care services for its members under the terms of their Individual and Group Health Plan membership contracts with the County. This contractor has been a part of the CCHP Provider Network since 2017 by providing non-emergency medical services to CCHP members.

On March 12, 2019, the Board of Supervisors approved Contract #77-062-3 with Medic

BACKGROUND: (CONT'D)

of Supervisors approved Contract Amendment Agreement #77-062-4 to increase the contract payment limit by \$150,000 to a new payment limit of \$1,050,000 to provide additional non-medical transportation/paratransit services for CCHP members with no change in the term through March 31, 2021.

Approval of Contract #77-062-5 will allow the contractor to continue to provide non-emergency medical transportation/paratransit services to CCHP members through March 31, 2024.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, certain specialized health care services for CCHP members under the terms of their Individual and Group Health Plan membership contracts with the County will not be provided.
