Subject: Contract #77-066-3 with Holistic Health Center of Walnut Creek, Inc.

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #77-066-3 with Holistic Health Center of Walnut Creek, Inc., a corporation, in an amount not to exceed \$525,000, to provide primary care physician services to Contra Costa Health Plan (CCHP) members for the period from April 1, 2021 through March 31, 2024.

FISCAL IMPACT:

This contract will result in contractual service expenditures of up to \$525,000 over a three-year period and will be funded 100% by CCHP Enterprise Fund II.

BACKGROUND:

CCHP has an obligation to provide certain specialized health care services for its members under the terms of their Individual and Group Health Plan membership contracts with the County. This contractor has been a part of the CCHP Provider Network since April 1, 2017.

On March 19, 2019, the Board of Supervisors approved Contract #77-066-1 with Anthony Lopresti, O.D. (dba MDI Wellness Center), in an amount not to exceed \$325,000, to provide

BACKGROUND: (CONT'D)

In October 2019, the County Administrator approved and the Purchasing Services Manager executed Assignment Contract #77-066-2 from Anthony Lopresti, D.O., (dba MDI Wellness Center) to Holistic Health Center of Walnut Creek, Inc., with no change in the contract payment limit of \$325,000 for the provision of primary care physician services for CCHP members with no change in the term of April 1, 2019 through March 31, 2021.

Approval of Contract #77-066-3 will allow Holistic Health Center of Walnut Creek, Inc., to continue providing primary care physician services for CCHP members through March 31, 2024.

CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, certain specialized health care services for CCHP members and County recipients under the terms of their Individual and Group Health Plan membership contracts with the County will not be provided.
