Subject: Contract Impact Justice

RECOMMENDATION(S):

APPROVE and AUTHORIZE the County Probation Officer, or designee, to execute a contract with Impact Justice in an amount not to exceed \$961,364 to assist the Contra Costa County Probation Department with planning for juvenile justice realignment for the term February 19, 2021 through April 1, 2025.

FISCAL IMPACT:

100% Juvenile Justice Crime Prevention Act (JJCPA) revenue.

BACKGROUND:

Under the orders of Governor Gavin Newsom, California will phase out the California Division of Juvenile Justice (DJJ) beginning in 2021. Starting in July, the state will cease all transfers of youth to the state's three remaining youth prisons. This will halt the transfer of youth to DJJ and require youth to remain under the supervision of individual Counties. This will allow youth to remain closer to family and community. However, it will require counties, including Contra Costa, to carefully determine the best way to provide supervision and essential services to youth who are high risk/high need, have committed serious crimes, and who would have otherwise received services at a locked facility.
