Subject: Contract #76-693-1 with Multimедical Systems, LLC

RECOMMENDATION(S):

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #76-693-1 with Multimедical Systems, LLC, a limited liability company, in an amount not to exceed \$296,400, to provide repair and maintenance of infection prevention equipment services at Contra Costa Regional Medical Center (CCRMC) and Health Centers for the period from May 1, 2021 through April 30, 2022.

FISCAL IMPACT:

Approval of this contract will result in annual expenditures of up to \$296,400 and will be funded as budgeted by the department in FY 2020-21, by 100% Hospital Enterprise Fund I revenues.

BACKGROUND:

Multimedical Systems, LLC. will provide trained biomedical technicians and employee services for the biomedical department. The biomedical department provides repairs and technical services to equipment throughout CCRMC and Health Centers as needed, and the department needs more personnel than currently hired to meet those demands. Since June 1, 2019, the contractor has provided repair and maintenance of infection prevention equipment

BACKGROUND: (CONT'D)

On May 12, 2020, the Board of Supervisors approved Contract #76-693 with Multimedical Systems, LLC in an amount of \$296,400, for the provision of repair and maintenance of infection prevention equipment services CCRMC and Health Centers, for the period from May 1, 2020 through April 30, 2021.

Approval of Contract #76-693-1 will allow this contractor to continue providing maintenance of infection prevention equipment services through April 30, 2022.
