Subject: Contract #26-395-24 with LocumTenens.com, LLC

**RECOMMENDATION(S):**

APPROVE and AUTHORIZE the Health Services Director, or designee, to execute on behalf of the County Contract #26-395-24 with LocumTenens.com, LLC, a limited liability company, in an amount not to exceed \$1,200,000, to provide temporary physician services at Contra Costa Regional Medical Center (CCRMC) and Contra Costa Health Centers, for the period March 1, 2021 through February 28, 2022.

**FISCAL IMPACT:**

This contract will result in contractual service expenditures of up to \$1,200,000 over a twelve-month period and is 100% funded by Hospital Enterprise Fund I.

**BACKGROUND:**

CCRMC has an obligation to provide certain specialized health care services for its members under the terms of their Individual and Group Health Plan membership contracts with the County. This contractor has been providing services to CCRMC and Contra Costa Health Centers since 2000, and provides temporary medical staff services to ensure patient care is provided during peak loads, temporary absences, vacations and emergency situations when additional staffing is required.

## BACKGROUND: (CONT'D)

On March 31, 2020, the Board of Supervisors approved contract #26-395-22 with LocumTenens.com in the amount of \$800,000 for the provision of temporary physician services at CCRMC and Contra Costa Health Centers for the period March 1, 2020 through February 28, 2021.

On January 19, 2021 the Board of Supervisors approved Contract Amendment Agreement #26-395-23 with Locumtenens.com to increase the payment limit from \$800,000 to a new payment limit of \$1,200,000 with no change in the term of March 1, 2020 through February 28, 2021.

Approval of Contract #26-395-24 will allow this contractor to continue providing temporary physician services at CCRMC and County Health Centers through February 28, 2022.

## CONSEQUENCE OF NEGATIVE ACTION:

If this contract is not approved, patients requiring temporary physician services will not have access to this contractor's services.
