### **FISCAL IMPACT:**

This contract will result in contractual service expenditures of up to \$380,651 and will be funded as budgeted by the department in FY 2021-22, by 100% Mental Health Realignment revenues. (Rate increase)

## **BACKGROUND:**

The Behavioral Health Services Department has been contracting with God's Grace Caring Home, Inc., since January 1, 1999 to provide augmented board and care services for mentally ill adults.

This contract meets the social needs of the County's population by augmenting room and board and providing twenty-four hour emergency residential care and supervision to eligible
