## **BACKGROUND:**

The Antioch Library will partner with the Antioch Unified School District in order to participate in Lunch at the Library, a project of the California State Library and California Summer Meal Coalition. The Lunch at the Library program provides children and teens with meals, summer reading programs, and other activities that support learning, health, and wellness. It also brings new families to the library where staff can connect adult family members with essential resources and services. Similar to the Lunch at the Library program in 2020, the Library will adjust this summer's Lunch at the Library program to conform with
